#### **PRESIDENT OF THE UNITED STATES**

Hillary Clinton is the first female to be nominated for president by any major political party in the United States. She formally accepted the Democratic Party's nomination for President of the United States on July 28, 2016.

She received her BA degree in political science in 1969 from Wellesley College. She then attended Yale law school where she graduated with honors in 1973. She also took several courses (1973 – 1974) on children and medicine at Yale Child Study Center.

She worked with US senator Walter Mondale in 1971 while she was attending Yale. The following year (1972), she worked with Democratic Presidential nominee George McGovern.

She met Bill Clinton while teaching at the University of Arkansas Law School, got married in 1975, and became the first lady of Arkansas from 1979 to 1981 and then again from 1983 to 1992. She became First Lady of the United States in 1993, the same year she led the unsuccessful effort to enact the Clinton Healthcare plan. At the 1995 UN conference on women, Hillary delivered a controversial and influential speech where she stated that "human rights are women's rights and women's rights are human rights". In 1997 and 1999 she helped create the State Children's Health Insurance Program.

In 2000, Hillary was elected as the first female senator from New York, and the only first lady ever to have sought elective office. She held the seat until 2009. During her time as a New York senator she took a leading role in investigating the health issues faced by September 11th First Responders.

In 2009, she was named the 67th United States Secretary of State, a title she held until she stepped down in 2013.

Hillary Rodham Clinton has been called the most qualified candidate for President of the United States in our nation's history.

#### What is a Democratic Party Committee Person?

Most committee persons are elected officials of the Democratic Party. Each voting precinct can have up to two committee persons, elected by the Democratic voters of that precinct once every four years in during a Gubernatorial Primary. You can also become a committee person by appointment, should a vacancy occur. A committee person represents the Democratic Party on behalf of the Democratic voters in a precinct. As a committee person, you assist the local and county Democratic committees with the business of electing Democratic candidates at the local, county, state, and national levels. You have a vote at your monthly area meetings and at the full Northampton County Democratic Committee meetings, including the re-organizational meeting held once every four (4) years.

To be on the ballot as a committee person, you must circulate a nominating petition during the Gubernatorial Primary and obtain at least 10 signatures of registered Democrats living in your precinct. To be elected, you must have the plurality of votes, including write in votes if not on the ballot.

#### VICE PRESIDENT OF THE UNITED STATES

Tim Kaine was born in Minnesota in 1958, but grew up near Kansas City, Missouri. His undergraduate work was at the University of Missouri, where he completed his bachelor's degree in economics in three years, before entering Harvard Law School. He took a year off from law school to volunteer with Jesuit missionaries in Honduras, where he ran a small vocational school for teenage boys while honing his Spanish. While there, Tim saw poverty up close, and the devastation it left in its wake. This experience became the catalyst for his longstanding commitment to social justice.

Tim began practicing law in Richmond, Virginia, after graduating from Harvard Law School in 1983. He devoted much of his time to pro-bono work, helped found the Virginia Coalition to End Homelessness and was a board member of the Virginia chapter of Housing Opportunities Made Equal.

Tim's political ascent began when he was voted to the Richmond City Council in 1994. This initial foray into politics eventually led to his election as Virginia governor in 2005. Following a stint as chairman of the Democratic National Party from 2009 to 2011, Kaine was elected to the U.S. Senate in 2012.

Tim became the first senator to deliver a speech in Spanish from the Senate floor. He introduced the Troop Talent Act of 2013 to help servicemen and women transition to the civilian workplace, and coauthored the Iran Nuclear Agreement Review Act of 2015. Additionally, he is a founder and co-chair of the bipartisan Career and Technical Education (CTE) Caucus, and has introduced legislation to address issues of sexual assault and drug treatment.

Katie grew up in Northeast Philadelphia, the ninth of ten kids. She learned the value of public service at home, from her dad who walked the beat as a police officer for more than 20 years.

With the help of scholarships and loans, Katie studied chemistry at Saint Joseph's University, the first in her family to attend a four-year college right out of high school, before heading to Columbia Law School.

From there, Katie earned a fellowship to go to Capitol Hill to work for Senator Al Gore. Senator Gore asked her to stay on as his top environmental advisor. She agreed, and put her science background to good use working with Republicans and Democrats alike to strengthen the Clean Air Act and take the first steps to address climate change.

In 1993, President Bill Clinton appointed Katie to be his top environmental aide and later to chair the White House Council on Environmental Quality, the first woman ever to hold this position. In this capacity, Katie helped deliver major gains on renewable energy and clean air and water — all the while proving that a safe environment and a strong economy can go hand-in-hand.

Katie and her husband Karl then went to India to study the ways in which the two nations could work together to fight climate change. Before moving back to Washington D.C., they adopted twin daughters, Tara and Alana.

Governor Ed Rendell asked her to serve as Secretary of the Department of Environmental Protection. In that role, she made it her mission to cross party lines and help bring leading renewable energy companies to Pennsylvania, putting 3,000 people to work in good paying clean energy jobs.

Since then, Katie has been a leader of several companies, continuing her work to protect the environment and promote clean energy. As Chief of Staff to Governor Tom Wolf, she led the charge to expand Medicaid to over 600,000 Pennsylvanians. Throughout her career, Katie has never lost sight of her working family roots or her love for the Keystone State.

Now, she's running to be Pennsylvania's first woman senator to rebuild the promise of the American Dream for working families like her own.

Katie lives in Wayne, Chester County, with her husband Karl, their daughters Tara, Alana, and Allie, and their dogs Marshall and Ginger.

Eugene A. DePasquale became Pennsylvania's 51st Auditor General January 15, 2013. As the state's chief fiscal watchdog, Eugene is committed to seeing that taxpayer dollars are spent properly and effectively.

Eugene is focusing audits on areas that will improve the lives of all Pennsylvanians and prepare our state for a brighter future. His audits have found fraud, errors and other financial issues in school districts and

charter schools to the tune of well over \$20 million. The audits also have shown how the state can do a better job of protecting drinking water and ensuring the humane treatment of animals.

In his first year as Auditor General, Eugene reformed his department by conducting an internal audit and making dramatic reforms to improve office efficiency and save an estimated \$2 million.

Eugene was born and raised in Pittsburgh. He received his law degree from Widener University School of Law, Master's from the University of Pittsburgh and undergraduate degree from the College of Wooster in Ohio. He is a graduate from Pittsburgh Central Catholic High School where he was a member of the state championship football team.

Eugene lives in York County with his wife Tracey, and their children, Ben and Sarah. He is active in his church and in coaching youth baseball.

Joe Torsella is a graduate of Wyoming Seminary high school in Kingston, Pennsylvania and an honors graduate of the University of Pennsylvania, Phi Beta Kappa, 1986, with a degree in economics and history. As a Rhodes Scholar (1986–1990), he did graduate work in American History at New College, Oxford.

Torsella served as Philadelphia's Deputy Mayor for Policy and Planning for Mayor Ed Rendell (later Governor of

Pennsylvania) from January 1992 to September 1993. He was not yet 30. Under Rendell, Torsella developed and implemented financial and labor reforms that led the city toward a fiscal rebound that the *New York Times* called "one of the most stunning turnarounds in recent urban history".

On August 13, 2008, Governor Edward G. Rendell named Torsella the Chairman of the Pennsylvania State Board of Education

On November 15, 2010, Torsella was nominated by President Barack Obama to the position of U.S. Representative to the United Nations for Management and Reform, with the rank of Ambassador.



Josh Shapiro serves as the Chairman of the Board of Commissioners for Pennsylvania's thirdlargest county where he is responsible for a budget of \$370 million and over 2,300 employees.

As the first Democrat to lead Montgomery County in 150 years, Josh put the County's fiscal house back in order after years of Republican deficits while standing up for progressive values.

He fired the Wall Street money managers who were ripping off retirees, helped issue the first marriage licenses to LGBT couples in Pennsylvania, and fought against voter ID laws that would make it more

difficult for young people, minorities, and seniors to vote.

As a State Rep., he took on the status quo, wrote and passed the farthest-reaching ethics laws in a generation, and established strict new financial controls over state spending. Philadelphia Magazine wrote that Josh "has been a blast of oxygen in the smokechoked back rooms of quid-pro-quo Harrisburg," and his work earned him a national reputation as a bipartisan consensus builder.

Josh also serves as Chairman of the Pennsylvania Commission on Crime and Delinquency, where he's worked to improve public safety in communities across the state by reforming the criminal justice system, better caring for victims of crime, and making prevention programs more effective.

Josh Shapiro graduated magna cum laude from the University of Rochester, earned his law degree at night from Georgetown University, and is a member of the Pennsylvania Bar. He has practiced law at Philadelphia-based Stradley Ronon for a decade. Josh was raised in Montgomery County, where he met his high school sweetheart, Lori, and where they are raising their four young children.

#### You DO NOT NEED a PHOTO ID to vote on November 8

#### ALL VOTERS *MAY* BE ASKED FOR A PHOTO ID, BUT MOST\* VOTERS CAN USE THE VOTING MACHINES WITHOUT ONE.

THE ONLY EXCEPTIONS ARE IF YOU ARE A FIRST-TIME VOTER OR VOTING FOR THE FIRST TIME AT A NEW POLLING PLACE: You must show either a photo ID or a non-photo ID. Must have name and address. Examples include: PA Driver's License; Military; Employee or Student ID; Passport; Current Utility Bill; Current Bank Statement; Current Pay Check; Government Check; or Voter Registration Card.
